Manufacturer Redemption Address Change

A NCH client moving to another agent or beginning to process in-house

Manufacturer Split

A NCH client who has sold products to another manufacturer



New NCH Manufacturer

A manufacturer new to NCH who may or may not have coupons in the marketplace
