### **Family Codes**

Family codes as provided by the manufacturer; may not be all-inclusive of the manufacturer's complete family code structure

### **Manufacturer Merger**

A manufacturer merging into an existing NCH client

### **Manufacturer Name Change**

A NCH client changing their corporate name

### **Manufacturer Redemption Address Change**

A NCH client moving to another agent or beginning to process in-house

### **Manufacturer Redemption Clarification**

Further details pertaining to NCH client company prefixes, brands, family codes, etc.

### **Manufacturer Split**

A NCH client who has sold products to another manufacturer

### **New NCH Manufacturer**

A manufacturer new to NCH who may or may not have coupons in the marketplace
